## What is the purpose of this update?


This document tells you how the Mercer Core Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

The fund invests in shares listed on share markets predominately in developed economies. The portfolio uses multiple managers and is diversified by region, manager and investment approaches. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a Gross Return<sup>1</sup> above the return of the MSCI World ex Tobacco Index with net dividends reinvested on a rolling three year basis.

# What are the risks of investing? Risk indicator for the Mercer Core Global Shares Fund:



## Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$1,574.00 (that is 15.74% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$1,574.00 for the year.


#### Actual investment mix
