Mercer Core Hedged Global Shares Fund¹ Mercer Investment Funds

What is the purpose of this update?

This document tells you how the Mercer Core Hedged Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests in shares listed on share markets predominately in developed economies and is fully hedged to the New Zealand dollar. The portfolio uses multiple managers and is diversified by region, manager and investment approaches. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a Gross Return² above the return of the MSCI World ex Tobacco Index with net dividends reinvested (139% gross hedged to the New Zealand dollar) on a rolling three-year basis.

What are the risks of investing? Risk indicator for the Mercer Core Hedged Global Shares Fund³:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



What fees are investors charged?

* In the year to 31 March 2022, the fund held units in underlying funds, which pay performance fees to the managers of the underlying funds. One of the managers of the underlying funds paid a performance fee rebate back to the fund for the year. This has resulted in other management and administration charges being negative in this fund update.

** There were no performance fees paid in underlying funds for the year to 31 March 2022. See the product disclosure statements that applied for the year ending 31 March 2022 for more information about the basis on which performance fees were calculated. As at 1 April 2022 there are no longer any performance fee arrangements in underlying funds.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Example of how this applies to an investor ⁷


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges were deducted of -\$596.00 (that is -5.96% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total loss after tax of -\$596.00 for the year.


Actual investment mix

Currency management

The fund targets a position of being 100% hedged to the New Zealand dollar (on a net of tax basis) with the hedges based on the currency weights of the underlying index. Currency hedges are normally rebalanced monthly but may be adjusted intra-month for significant cash flows. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 31 March 2023 was 100.30%.

Notes

1. On 3rd March 2023, Mercer (N.Z.) Ltd became the manager of the fund. The previous manager was Macquarie Asset Management Public Investments (NZ) Limited. From 3rd March 2023, the Macquarie Core Hedged Global Shares Fund is called the Mercer Core Hedged Global Shares Fund.

2. Gross Return is the return before the deduction of tax, expenses and fees and assumes all income is reinvested.

3. In previous quarters, the risk indicator has been calculated based on the weekly returns of the Fund. The basis of the risk indicator has changed to the monthly returns to be consistent with other investment options managed by Mercer (N.Z.) Ltd.

4. These returns are for the periods ending 31 March 2023.

5. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.

6. GST is currently charged at 15% on 10% of the management fee in accordance with the non- binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry. GST on management fees is currently under review and therefore this percentage may change in the future.

7. The returns and tax calculations used in this example are the actual fund returns and tax charges (or rebates) for the year ended 31 March 2023. Net of tax returns can be more than gross of tax returns where, due to the fund's tax position, it receives a tax rebate rather than paying tax.
