## Macquarie Investment Funds

### Macquarie Global Shares Fund<sup>1</sup>

This fund update was first made publicly available on: 31 October 2022

#### What is the purpose of this update?

This document tells you how the Macquarie Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Macquarie Asset Management Public Investments (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The fund invests in international shares listed on share markets around the world by using investment managers from around the world which are combined in a multi-manager fund.

Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes where applicable.

Investments are spread across a range of international share markets, including developed and emerging economies. The portfolio is further diversified by region, manager and investment approach with the aim of delivering more stable returns.

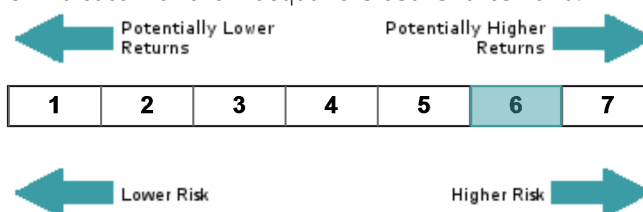
The fund targets a position of being 69% gross hedged to the New Zealand dollar with the hedges based on the currency weights of the underlying index. Currency hedges are normally rebalanced monthly but may be adjusted intra-month for significant cash flows.

The performance objective of the fund is to provide a Gross Return (see note 2 below) above the return of the MSCI All Country World ex Tobacco Index with net dividends reinvested (69% gross hedged to the New Zealand dollar) on a rolling three year basis.

#### What are the risks of investing?

Risk indicator for the Macquarie Global Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

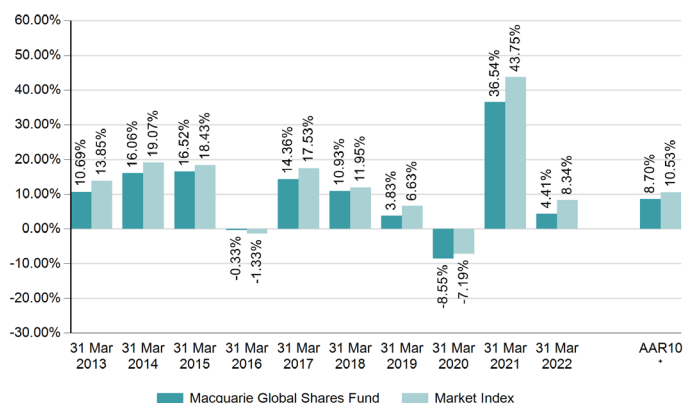

#### How has the fund performed?

## What fees are investors charged?

Investors in the Macquarie Global Shares Fund are charged fund charges. In the year to 31 March 2022 these were:

\* The fund holds units in underlying funds, which pay performance fees to the managers of these underlying funds. In the year to 31 March 2022 the manager of one of these underlying funds paid a performance fee rebate back to the fund. This has resulted in other management and administration charges being negative in this fund update

## Example of how this applies to an investor<sup>5</sup>

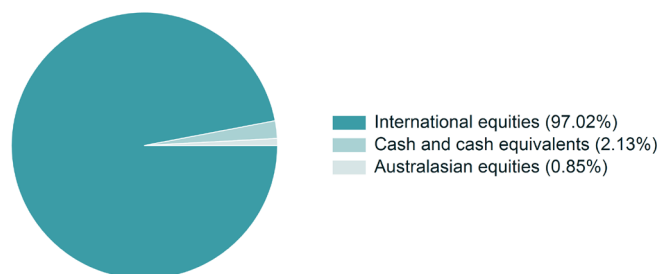
Small differences in fees and charges can have a big impact on your investment over the long term.

Jeff had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jeff received a return after fund charges were deducted of \$552 (that is 5.52% of his initial \$10,000). This gives Jeff a total return after tax of \$441 for the year.

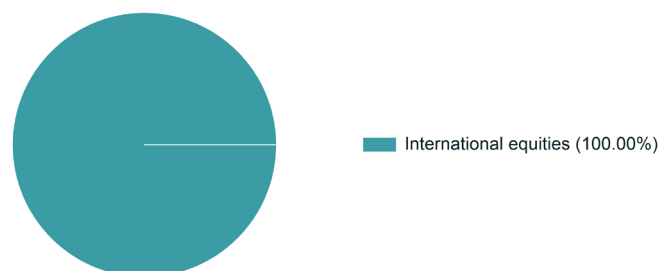

## Notes

1. In March 2022, Macquarie Asset Management Holdings Pty Limited completed the acquisition of the AMP Capital Global Equities and Fixed Income business from AMP Group Holdings Limited. Prior to that acquisition, Macquarie Asset Management Public Investments (NZ) Limited was known as AMP Investment Management (N.Z.) Limited and the Macquarie Global Shares Fund was known as the AMP Capital Global Shares Fund.

3. These returns are for the periods ending 30 September 2022.
4. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.
