# Mercer Income Generator Fund<sup>1</sup> Mercer Investment Funds

#### Quarter ending 31 March 2023

This fund update was first made publicly available on: 3 May 2023.

## What is the purpose of this update?

This document tells you how the Mercer Income Generator Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The fund aims to provide a gross fixed monthly income in excess of bank deposit rates, along with a positive return on capital over the long term. To achieve this, the fund invests in a diversified mix of growth and defensive assets, with a focus on reliable income generation. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes.

The fund aims to maximise the amount of the monthly distribution payments to investors by outperforming, over the medium term, the weighted average return of the market indices used to measure performance of the underlying funds/assets in which the fund invests.

## What are the risks of investing?

**Risk indicator for the Mercer Income Generator Fund<sup>2</sup>:** 



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



The market index annual return is based on the weighted average return of the market indices used to measure performance of the underlying funds/assets. The market index for the "NZ Fixed Interest" portion of the Fund has changed from the Bloomberg NZBond Infl 0+ Yr Index to the Bloomberg NZBond Composite 0+ Yr Index since the last fund update. #### **Annual Return Graph**<sup>4</sup>

## Example of how this applies to an investor <sup>6</sup>


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges were deducted of -\$229.00 (that is -2.29% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total loss after tax of -\$229.00 for the year.


#### Actual investment mix

The top 10 investments make up 17.94% of the fund.

#### **Currency management**

The assets included in the international listed property category are hedged back to New Zealand dollars. For the international listed infrastructure category, the currency weights of the underlying index are hedged back to New Zealand dollars. The assets included in the global corporate bonds category are also hedged back to New Zealand dollars. The Australian dollar assets are not currently hedged, but the investment manager retains discretion to adjust this exposure. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 31 March 2023 was 77.20%.

## Notes

1. On 3rd March 2023, Mercer (N.Z.) Ltd became the manager of the fund. The previous manager was Macquarie Asset Management Public Investments (NZ) Limited. From 3rd March 2023, the Macquarie Income Generator Fund is called the Mercer Income Generator Fund.

2. In previous quarters, the risk indicator has been calculated based on the weekly returns of the Fund. The basis of the risk indicator has changed to the monthly returns to be consistent with other investment options managed by Mercer (N.Z.) Ltd.

3. These returns are for the periods ending 31 March 2023.

4. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.

5. GST is currently charged at 15% on 10% of the management fee in accordance with the non- binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry. GST on management fees is currently under review and therefore this percentage may change in the future.

6. The returns and tax calculations used in this example are the actual fund returns and tax charges (or rebates) for the year ended 31 March 2023. Net of tax returns can be more than gross of tax returns where, due to the fund's tax position, it receives a tax rebate rather than paying tax.
