Mercer Macquarie Australian Shares Fund Mercer Investment Funds

What is the purpose of this update?

This document tells you how the Mercer Macquarie Australian Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund is a diversified portfolio of Australian shares across a range of industries and sectors. Environmental, Social and Governance characteristics are integrated into the underlying investment manager's investment process. The fund aims to provide a Gross Return¹ above the return of the S&P/ASX 200 Accumulation Index (in NZD) on a rolling three-year basis.

Total value of the fund \$355,467,631

What are the risks of investing? Risk indicator for the Mercer Macquarie Australian Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$1,543.00 (that is 15.43% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$1,543.00 for the year.



What does the fund invest in?


Actual investment mix
