What is the purpose of this update?

This document tells you how the AMP Capital Global Short Duration Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Investment Management (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund is a diversified portfolio of highly rated global fixed interest securities. At the total portfolio level the fund will have a shorter maturity than most traditional fixed interest funds, with an emphasis on minimising capital loss.

The fund takes advantage of global opportunities, focusing on active positions on long-term trends as opposed to short-term aberrations in interest rates. Investment is in a selection of short duration international fixed interest securities, including international government and government-related securities, and corporate debt.

Environmental, Social and Governance characteristics are integrated into the underlying investment manager's investment process.


The fund is fully hedged to the New Zealand dollar.

The performance objective of the fund is to provide a Gross Return (see note 1 below) above the return of the Bloomberg NZBond Bank Bill Index on a rolling three year basis.

What are the risks of investing?

Risk indicator for the AMP Capital Global Short Duration Fund (see note 5 below):



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor4


Small differences in fees and charges can have a big impact on your investment over the long term.

Jeff had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jeff received a return after fund charges were deducted of \$201 (that is 2.01% of his initial \$10,000). This gives Jeff a total return after tax of \$144 for the year.

Notes

- Gross Return is the return before the deduction of tax, expenses and fees and assumes all income is reinvested.
- 2. These returns are for the periods ending 31 December 2021.
- The bar chart shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.
- 4. The returns and tax calculations used in this example are the actual fund returns and tax charges (or rebates) for the year ended 31 March 2021. Net of tax returns can be more than gross of tax returns where, due to the fund's tax position, it receives a tax rebate rather than paying tax.
- 5. In December 2021, the fund's strategy changed and the fund's exposure to international fixed interest is now achieved through an investment in the Macquarie Global Income Opportunities Fund. The risk indicator above is based on the returns data for the Macquarie Global Income Opportunities Fund for the last five years. The risk indicator for the Global Short Duration Fund is based on a combination of the Macquarie Global Income Opportunities Fund return up until 30 November 2021 and then actual Fund returns from 1 December 2021.
