What is the purpose of this update?

This document tells you how the AMP Capital Global Property Securities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Investment Management (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests in a global portfolio of listed property securities in North America, Europe, Asia and Australasia. It aims to generate medium to high returns over the long term by investing in a broad range of property regions, sectors and securities through a single fund. Greater diversification is achieved by accessing a range of property companies and sectors not available in the New Zealand listed property market. There is also a focus on property securities whose primary source of revenue is rental income. International investment specialists are able to capitalise on local knowledge and identify the best opportunities in each region.

Environmental, Social and Governance characteristics are integrated into the investment process.


The fund targets a position of being fully hedged to the New Zealand dollar.

The performance objective of the fund is to provide a Gross Return (see note 1 below) above the FTSE EPRA/NAREIT Developed Total Return Index with net dividends reinvested, fully hedged to New Zealand dollars, on a rolling three year basis.

What are the risks of investing?

Risk indicator for the AMP Capital Global Property Securities Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor4


Small differences in fees and charges can have a big impact on your investment over the long term.

Jeff had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jeff received a return after fund charges were deducted of \$2,662 (that is 26.62% of his initial \$10,000). This gives Jeff a total return after tax of \$2,553 for the year.


