

Fund update

Mercer Macquarie Global Listed Real Estate Fund Mercer Investment Funds

Quarter ending 30 September 2023

What is the purpose of this update?

This document tells you how the Mercer Macquarie Global Listed Real Estate Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests in a global portfolio of property securities listed on stock exchanges around the world. It aims to generate medium to high returns over the long term by investing in a broad range of property regions, sectors and securities through a single fund. Environmental, Social and Governance characteristics are integrated into the investment process. The fund aims provide a Gross Return¹ above the FTSE EPRA/NAREIT Developed Total Return Index with net dividends reinvested, fully hedged to New Zealand dollars, on a rolling three-year basis.

What are the risks of investing?

Risk indicator for the Mercer Macquarie Global Listed Real Estate Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges were deducted of -\$167.00 (that is -1.67% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total loss after tax of -\$167.00 for the year.


Actual investment mix
