

## **Fund update**

### Mercer Macquarie NZ Cash Fund Mercer Investment Funds

#### What is the purpose of this update?

This document tells you how the Mercer Macquarie NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The fund is an actively managed portfolio of bank bills, floating rate notes and short term securities and liquid deposits, and is a low risk investment product that targets capital security. Environmental, Social and Governance characteristics are integrated into our investment process where applicable. The fund aims to provide a Gross Return<sup>1</sup> above the return of the Bloomberg NZBond Bank Bill Index on a rolling 12-month basis.

# What are the risks of investing? Risk indicator for the Mercer Macquarie NZ Cash Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



#### **Example of how this applies to an investor**


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$412.00 (that is 4.12% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$412.00 for the year.


#### **Actual investment mix**
